

IMPACT MAP CANVA

If you're thinking of creating a startup that will help address one or more of the social and/or environmental issues we face today, you should map your creation's core and operational impact using this canva.

We've been witnessing the regular launch of many such startups, ones variously categorized as impact startups, sustainability startups, social entrepreneurship and greentech.

As you can see, the notion of positive impact is integral to these category titles and to the missions and/or statements attached to them. And since their purpose is to maximize positive impact in their chosen areas, it is crucial that startup creators map these impacts, and that they deliberate on the hypotheses and assumptions of change their organizations wish to bring to the world.



When should you use Impact Map Canva?

- When you have an idea for a startup that focuses on the environmental or social problem, this canva will help you to develop your first Theory of Change and link it to Sustainable Development Goals. It will also help you to form a vision of how you want to operate and how you will avoid risks and negative impacts.
- When you've established your startup already; where social and environmental challenges are at the heart of its activities and where you intend to maximize positive impact—as well as to measure and manage it.
- When you want to start seeking Impact Investor for your startup.

 Analyzing an Investee's Theory of Change is usually the first step in the investor's due diligence process.



If you're one such creator, here's a step-by-step tool we've developed for you to facilitate this process. It is a canva based on 4 main assumptions:

- Agenda 2030 and its 17 Sustainable Development Goals with its 169 targets and 231 unique indicators is mutually agreed upon, accepted compass for the world to navigate through our current global challenges. This can only be achieved by working together. Therefore, we believe it is important that such challenges be linked to one or more Sustainable Development Goals and their targets and indicators.
- Theory of Change (ToC) is a methodology used by organizations to define and illustrate the social change they wish to bring about. ToC is a logic model linking targeted social issues with specific activities, expected outputs and outcomes.
- We see 'impact' as the Global Reporting Initiative defines it: Impact refers to the effect an organization has or could have on the economy, environment, and people, including effects on their human rights, as a result of the organization's activities or business relationships. The impacts can be actual or potential, negative or positive, short-term or long-term, intended or unintended, and reversible or irreversible. These impacts indicate the organization's contribution, negative or positive, to sustainable development (...).1

We believe that any organization, regardless of whether it has a social or environmental problem at its core, has its impacts on governance, environment, society, and customer/beneficiaries. It is important, therefore, that an awareness of these impacts be heightened.


Stakeholders—defined as individual or group that has an interest that is affected or could be affected by the organization's activities.²
When it comes to identifying and assessing impacts, stakeholders remain central. Theirs is the voice you should listen to most attentively, so we encourage you to engage them in this process as soon as possible.

How to use this canva?

- Chosen challenges—begin by selecting from the Sustainable Development Goals your idea seeks to address. Then select your targets and unique metrics. Find all required information here: https://sdgs.un.org/
- Core activities addressing SDGs—list the activities through which you intend to address the challenges you've identified. Your ideas and solutions are based on the knowledge and assumptions you have remember to list all the resources, questions and risks you envision at this stage.
- Outputs—here are tangible, measurable effects from the activities in the previous step. For example, the number of training sessions and number of participants. Here is also for noting all the assumptions, questions, risks you feel will need testing and verification.
- Outcomes—here are the changes that can result from your actions. For example, participants may gain skills, knowledge and a broadened social network. This is also a stage where you may have assumptions, questions and risks listed for verification and testing.

- Define your impact—envision the long-term change you see as resulting from your actions and their outcomes.


 For example: your target group finding stable jobs and fulfilling their potential. Again, it is important to list all assumptions, questions and risks you foresee at this point.
- Operational impact—this is dedicated to all impacts that result from the operation of your organization. Although your organization will have impact at its core, you must ensure that no limits are exceeded and that you have a positive impact on employees, environment, wider society, governance, and customers. For a better visualization of this impact, we recommend that you review GRI Standards or B Impact Assessment questions from B Lab, and that you reflect on all assumptions, questions and risks for later verification and testing.
- Setting a first impact model is a process that will be based on several assumptions and one to require the application of just as many hypotheses. We therefore recommend instead that this model be understood as a continuous cycle. This means continual re-iteration so that all hypotheses and assumptions are tested accordingly, and that the results of these tests be communicated to and validated with all stakeholders.
